Rules of the Huddersfield Canal Society 220 Club

1. The name of the Club is the 'Huddersfield Canal Society 220 Club' (the Club).
2. The object of the Club is to raise funds for the 'Huddersfield Canal Society Limited' (HCS).
3. Membership of the Club shall be limited to persons over 18 years of age who are also members of HCS.
4. The annual subscription to the Club shall be £24, payable either on admission to the Club or by monthly payments of £2 paid by standing order. The annual subscriptions may be paid by cheque or standing order for £24 annually. A member may hold more than one membership of the Club.
5. Prizes will be drawn four times each year, in January, April, July and October. There will be a first prize of £350 and a second of £175 drawn on each occasion.
6. The above prizes are based on a membership of 220. In the event of application forms being received from more, or less than, 220 people, the scale of prizes will be proportionally increased or reduced.
7. Payment in full for the 3 months preceding the draw must have been received by the Club for a member to be eligible for the Draw.
8. All winners will be notified by post. A list of prize winners will also appear in Pennine Link magazine.
9. The Club shall be administered by three Officers appointed annually by the Council of Management of HCS. The officers shall select one from amongst their number to be responsible for keeping the accounts of the Club and arranging for the payment of prizes and the transfer of surplus income to HCS. These rules may be amended by the Officers. The decision of the Officers in any matter relating to the operation of the Club shall be final and binding.
10. The Accounts of the Club shall be kept by the Officers and shall be examined annually by a suitably qualified person. The Officers shall keep a roll of membership and each membership shall be allocated a roll number.
